Happy Summer from MACPO's Legislative Committee,

Since the end of the session Sherry has been letting us know what happened during the session. Many of you may have heard our Legislative Update at the Awards Dinner at the conference, but not a whole lot happened in the areas that concern us. I can e-mail a copy of Sherry's report on what passed & what didn't. Just e-mail me a request & I will reply as soon as I can.

Remember that all 201 seats in both the House & Senate are up for election this fall, so there will be a lot of campaigning going on all over the state. Take the time to talk to the candidates about: Probation, and the impact of cuts in probation funding. There is no doubt that there are going to be some fledgling Senators and Representatives when they convene next year, and most of them aren't going to know much, if anything, about probation or corrections. Offer to be a resource for them when they go to St Paul next winter.

The 2013 session is supposed to be a Budget session for the 2014/15 Biennium. There are rumors that tax receipts are doing better than projected, so the deficit may not be as bad as anticipated, \$1 billion instead of \$1.8 billion. Regardless we plan on pressing for increased funding for probation.

The Committee plans on meeting again in August. We typically meet at 12:30 on the first Thursday of the month, at the DOC Central Offices. We will be starting the process of deciding or priorities for our initiatives for the next session. Anyone interested in being a part of our committee, or just attending is certainly welcome.




#### AL REKER DISTINGUISHED SERVICE AWARD WINNER Curtis Johnson and Dennis Larson, "The Wheaton Warriors"

The Minnesota Association of County Probation Officers (MACPO) was proud to present its prestigious Al Reker Distinguished Service Award to Curtis Johnson and Dennis Larson at the 55th Annual Conference on May 24th, 2012. The Al Reker award is bestowed to a member annually to recognize contributions made by an individual over a sustained period of time in the field of probation. Further, this award is to acknowledge exemplary contributions and dedication to the profession of probation/parole.

Curtis Johnson graduated from Concordia College in Moorhead, MN in 1970. He started his career as a Probation Officer in Fargo, ND. He was

There are different ways to define it, but a wonderful barometer of professional achievement is maintaining and serving five counties in West Central Minnesota for over 40 years has that distinction. Through many changes in administrations, Judges, Sheriffs Offices, politics and demographics, a staple combination of Court Services has faced all these, and despite the changing times, Curt and Dennis have kept the basic concept of probation strong and effective. Dennis and Curt have served the communities of those counties in a high level, with continual local and state satisfaction. How many young offenders were helped by their guidance and care? This means they have had to figure out how to cover court hearings in five counties, appease five different county boards, and get to offenders who are the true meaning of the word "rural". The award winner may have implemented a new corrections program, worked in the community to bring new corrections related services to clients or simply is an incredibly hardworking individual who merits recognition.

Bobbie is an exemplary supervisor and currently supervises two units in the Sher-



burne County Probation Department, both the Court and Juvenile Units. Bobbie demonstrates strong leadership skills and has the ability to positively motivate, supervise and discipline staff when necessary. Bobbie is a role model and works well with all Probation Department staff.

During 2011 the Probation Department was with out both the Adult Unit and Support Unit Supervisors for a significant amount of time. As a result Bobbie took on additional tasks to ensure the effective functioning

of the department, including supervision of additional staff and all the related is-

Bobbie continually researches state and federal laws and during 2011 she developed several additional policy and procedures including updating our department's Data Practices policy which is also utilized by numerous agencies across the state. Bobbie represents our department on the county OHP screening team and works closely with Health & Human Services to monitor and approve billing/payments made to vendors. Over the past three years, Bobbie's oversight of our juvenile out of home placements (OHP) has resulted in significant reductions in both placements and cost. In 2011 our Department's OHP budget was reduced by over \$500,000 and we have experienced an over savings of over \$1,500,000 over the past 3 years.

Bobbie coordinates and represents the department on numerous committees, including the Sherburne County Safe Schools, she organized and Chairs' the Metro Juvenile Supervisor Committee. Bobbie is well respected throughout the Minnesota Corrections Community; she is strong, confident and not afraid to express her opinion. Bobbie is respected by all department staff and manages both of her units exceptionally well.

In all areas Bobbie exemplifies the term "Outstanding Performance" and without reservation I absolutely, positively and unequivocally nominate Bobbie Shafer for

#### **EXCELLENCE IN CORRECTIONS AWARD**

#### Tracy Bachman and Kelley Lang Mower County Truancy Program

The Minnesota Association of County Probation Officers (MACPO) presented the Excellence in Corrections Award to Tracy Bachman and Kelley Lang and the Mower County Truancy Program at the 55th Annual Conference on May 24th, 2012. This award is given to recognize a corrections program which has demonstrated outstanding leadership and development in the field of probation.

The Excellence in Corrections Award nomination was submitted by Steve King, Director of Mower County Correctional Services.

I wish to take this opportunity to nominate the Mower County Truancy Program and our hard working, dedicated Truancy Counselors Kelley Lang and Tracy Bachman for the Excellence in Corrections Award.

Mower County has had a Truancy Prevention Program since 1999 and Tracy and Kelley have been actively serving in this capacity since 2002 and 2006 respectively. The truancy program is highly regarded in the Austin community and by school personnel. The level of credibility that this program has garnered rests solely on the relationships these two have built, fostered and maintained between Mower County Corrections and the local school systems. Tracy and Kelley are well known and respected within the schools and they are often invited to serve on school committees, participate as event chaperones and are active in on-going weekly team meetings. This level of participation, cooperation and responsivity has been instrumental in the school districts continued financial support of the Mower County Truancy Program. The schools are not alone in showing appreciation for this program. Local law enforcement and the Mower County Attorney's Office have come to know Tracy and Kelley as extremely competent corrections professionals. It has become common, almost nauseating at the amount of compliments I hear from our professional partners regarding Ms. Lang and Ms. Bachman and the good work they do. Their reputation is rooted in their comprehensive approach to truancy and the effect it has on juvenile offenders and public safety. They understand that in most cases successful intervention includes involvement from far more entities than just the offender, their parents and families. This level of involvement is often frustrating and time consuming but Kelley and Tracy persevere with professionalism and positive attitudes.

#### **Executive Board Goals:**

- Review the vision statement on an annual basis at the steering committee meeting.
- Use MACPO's APPA Affiliate Membership to send our President (or assigned representative) to the national conference to maintain/promote our presence on a national level, to be reviewed annually.






#### SAMHSA has released *Preventing* Suicide: A Toolkit for High Schools

This toolkit represents the best available evidence and expert opinion on preventing suicide among high school students. It provides schools with recommended steps and accompanying tools to guide them in creating and implementing strategies and programs that prevent teen suicide and promote behavioral health among their students.

Preventing Suicide: A Toolkit for High Schools will help schools and their partners: Assess their ability to prevent suicide among students and respond to suicides that may occur. Understand strategies that can help students who are at risk for suicide. Understand how to respond to the suicide of a student or other member of the school community. Identify suicide prevention programs and activities that are effective for the needs of individual schools. Respond to the needs and cultures of each school's students. Integrate suicide prevention into activities that fulfill other aspects of the school's mission such as preventing the abuse of alcohol and other drugs.



## Discover Corrections Today

Recruiting and retaining qualified individuals present challenges for community corrections. Among these are: how people seek and keep employment; the salary and benefit differentials between corrections and traditional local law enforcement; the negative image of corrections as portrayed in the popular media; competition to hire public service workers from the military, law enforcement and homeland security; and the demanding nature of the work that we do. In addition, the selection, recruitment, and retention of corrections workers is further influenced by the decreasing number of workers to fill an increasing number of positions being vacated by the current leaders within the corrections system as they retire.

To address these and other workforce development issues in corrections, the Bureau of Justice Assistance (BJA) funded a competitive award to the Council of State Governments/American Probation and Parole Association (CSG/APPA) to develop and implement the Discover Corrections website. Due to the wide ranging nature of the corrections field, the planning, development, and implementation of the website was a collaborative effort overseen by core project team of corrections stakeholders including APPA, the American Correctional Association (ACA), American Jail Association (AJA), and the Center for Innovative Public Policies (CIPP). After two years in development, we are pleased to announce the site is now available at <a href="https://www.DiscoverCorrections.com">www.DiscoverCorrections.com</a>!

A key feature of Discover Corrections is its job board. Once registered, agencies can share information about their agency and location to pique the interest of job seekers, and post job openings, search resumes, and receive resume alerts of job seekers that meet specified criteria. For job seekers, individuals who register on the site may: review job listings, save searches, post resumes, receive job alerts by email, and apply to jobs.

Discover Corrections is more than just a job board. In addition to the Find/Post Your Jobs section of the site, there are three other main categories of the site: Why Corrections, Explore the Field, and Career Resources. Here people can learn some of the primary reasons corrections is an appealing career choice; review comprehensive information about the many types of job opportunities throughout community corrections, jails and detention, and prisons and institutions; read personal stories from people working in corrections to learn more about the community nuances of various jobs; and learn how corrections is organized within each state.

Now that the website is operational we are reaching out to community corrections agencies to educate you about the site and encourage you to register your agency's profile and post job openings. Ultimately, this site was created for you! So take some time to review the site to become familiar with the resources it provides. If you are an employer, we want www.DiscoverCorrections.com to be the first place you think of to find new hires. If you are looking for a job, we want it to be the first resource you think of for your job search.

With BJA's continued support, APPA and its partners will continue to create new content for the site in the coming year. For example, we plan to enhance information on the site related to, but not necessarily limited to, Indian Country jails and juvenile facilities. A mobile version of the job board is also in development.

Scott Collier, A DEA investigator, says this synthetic drug is very dangerous and has effects similar to cocaine and meth. Meaning, if you use this drug you could hallucinate, have a seizure, or even die. This drug is also addicting.



## Grandma's pot cookies land California toddler in hospital By msnbc.com staff and wire reports

A three-year-old California boy was rushed to the hospital after apparently eating marijuana-laced cookies.

The family believes the boy got into his grandmother's stash of chocolate-chip pot cookies, tucked away in a garage refrigerator, one day earlier.

The family called police around 10:30 a.m. the next day when the toddler would not wake up after a long night's sleep, and they realized he may have eaten the cookies, according to a press release from the Murrieta Police Department.

The boy's grandmother, who had been diagnosed with cancer, had a doctor's recommendation for medical marijuana to treat her pain and help her sleep, Sgt. Phil Gomez told The Press-Enterprise newspaper. When the father returned that afternoon, he noticed crumbs on the garage floor and assumed the child's grandmother had been into the cookies, the Press-Enterprise reported.

The boy fell asleep around 5 p.m., Gomez said. The family didn't become concerned until the next morning, however, when they couldn't wake him up.

At that point, Gomez said, the father mentioned noticing the crumbs and decided to call police.

The boy was admitted to a local hospital for observation and later released.

It is not known how much the boy ate, but the child's grandmother said a silver-dollar-size bite had been enough to make her sleep, the Press-Enterprise reported.

"It's unfortunate that they didn't take better steps to keep those cookies out of reach of the child," Gomez said. "[The grand-mother] claims she's not going to make them ever again."

Police have not released the names of the family members and said the investigation is ongoing. No arrests have been made.

Investigators are awaiting the results of a toxicology test. If traces of marijuana are found in the boy's system, Gomez said, family members could potentially face a child endangerment charge.

#### The following is an excerpt from NAMI's Legislative Update:

Bullying Task Force Delivers Recommendations to Governor Dayton

The Governor's Task Force on the Prevention of School Bullying delivered their final report to Governor Dayton on Wednesday. The report, titled "Safe and Supportive Minnesota Schools" includes eight recommendations for the Governor and Legislature to consider:

- 1) Repeal existing, ineffective statutes, and replace them with a stronger law based upon the Task Force's recommendations.
- Adopt the recommended definitions pertaining to bullying, harassment, and intimidation to increase effective identification and response to these issues.
- 3) Establish baseline policies within every school district that emphasize the equal, strong protection of all students.
- 4) Create policies and practices that enhance communication between school personnel, students, parents, and communities to help develop strategies and techniques to reduce bullying.
- 5) Create a uniform, baseline data collection system regarding bullying issues to facilitate monitoring of these issues.
- 6) Create interagency and interdepartmental collaborations within the State of Minnesota to assist schools in their anti-bullying efforts.
- 7) Create a "School Climate Center" within the Minnesota Department of Education to:
  - \* Provide information and assistance to schools in their anti-bullying efforts
  - \* Improve safe-learning spaces for students, school-wide
  - \* Increase discipline, with a focus on remediation in all cases of bullying, harassment, or intimidation.
- 8) Make resources available to fund these efforts on both the state and local levels.

The report calls for swift action by the Governor, Legislature and other stakeholders to implement these recommendations as soon as possible. #### 'From What Works to What Matters' presents the North American premiere of the film, 'The Road from Crime'

The exit at the prison gate often appears to be a revolving door with nearly 60 per cent of released prisoners re-offending within two years of their release. Prisons and probation departments have, almost literally, tried everything in efforts to rehabilitate offenders over the past century, but the results have been uniformly bleak leading many to conclude that "nothing works." In the past ten years, however, a group of criminologists have hit upon what should have been an obvious source of inspiration for prisoner rehabilitation — the other 40 percent!

In this timely and compelling documentary, Allan Weaver, a Scottish ex-offender turned probation officer (author of the book, So You Think You Know Me?) asks a simple question: What can we learn from those former prisoners who have successfully "desisted" from criminal behavior or "gone straight?"

Starting where it all began for him on the streets of his home town and in Barlinnie Prison in Glasgow, Scotland, Allan sets off to understand how individuals like himself get caught up in cycles of crime and punishment, and how they break out of these patterns and move on to new lives. This journey takes him across the U.K., meeting an array of ex-prisoners and ex-prisoner activist groups, probation leaders, and criminological experts from London to Washington, DC.

He discovers that much of what the criminal justice process does actually leads to more re-offending through the labeling and stigmatization of ex-offenders. Indeed, few ex-prisoners say they were "rehabilitated" by the criminal justice system, but many blame their experiences with the justice system for keeping them trapped in cycles of crime and punishment.

Allan learns that real change more typically involves processes of self-discovery and mutual support. He discovers that 'desistance' from criminality is an internal change process although it is almost never done without support from the outside. Ex-prisoners speak in detail about the remarkable people who believed in them when others had lost hope, and about realizing that they too had something to offer others, including, for many, their children. Desistance for them is about realizing one is more than just the sum of one's crimes and re-discovering one's humanity, potential, and true self.

The big question — especially pressing for Allan as a probation officer — is whether we can bottle and package these often intangible dynamics into our criminal justice interventions? Can criminal justice processes be improved by a better understanding of how the change processes in desistance from crime really work? How would the criminal justice system be different if it were run by people like Allan who had been through the process themselves?

To answer this, Allan finds a fascinating world of ex-prisoner-led mutual aid and activist groups championing a new model of criminal justice practice. Like Allan, many of the ex-prisoners find meaning and purpose in their lives by helping others to avoid the mistakes they made. They might also have the answer for tackling the enduring problem of criminal recidivism."
