The Department of Public Safety Office of Justice Programs (OJP) is pleased to sponsor the 2010 OJP Conference on Crime and Victimization: Making Connections. This year's conference will be held May 26- May 28, 2010, at Cragun's Conference Center in Brainerd, Minnesota.

OJP provides leadership and resources to reduce crime in Minnesota, improve the functioning of the criminal justice system, and assist crime victims. Crime and victimization greatly undermine the quality of life in Minnesota communities. This event brings professionals together to review current research, improve skills, share information, and network with peers. The conference will allow participants an opportunity to discuss and strategize ways to address long-standing barriers to providing high quality services. Through efforts to form multi-disciplinary approaches and to explore the root causes of these issues, we can work together to combat the cycle of violence, crime, and victimization.

The 2010 Dr. William Kosiak Memorial Award and the Distinguished Service Award will be presented at the conference. The Kosiak Memorial Award recognizes exceptional service to crime victims by a volunteer, while the Distinguished Service Award acknowledges outstanding service to crime victims by a paid professional.

OJP provides scholarship opportunities for eligible participants to attend the conference. Scholarship categories include individual victim service provider and victims/survivors, criminal justice, student, and immigrant professionals.



One in Thirty One

Explosive growth in the number of people on probation or parole has propelled the population of the American corrections system to more than 7.3 million, or 1 in every 31 U.S. adults, according to a report released by the Pew Center on the States. The vast majority of these offenders live in the community, yet new data in the report finds that nearly 90 percent of state corrections dollars are spent on prisons. One in 31: The Long Reach of American Corrections examines the scale and cost of prison, jail, probation and parole in each of the 50 states, and provides a blueprint for states to cut both crime and spending by reallocating prison expenses to fund stronger supervision of the large number of offenders in the community.



Legislative Committee Report

As expected, the primary focus of the 2010 Legislature is on the bonding bills and on the State's budget deficit. Even with the reduction of the deficit from \$1.2 billion to \$994 million, we can expect serious reductions. At the time of this writing, the Governor has made his recommendations and the Senate has made theirs. We could see a 3% cut to DOC's Community Services budget which includes our CPO reimbursement as well as CCA's funding. On top of this, counties are expecting additional reductions in their "pass through" funding which will impact our local department budgets.

At times like these, it is easy to just focus on the negative and pull yourself into a "turtle shell of negativism". Instead, we need to continue to push for adequate probation funding and the voluntary implementation of Evidenced Based Practices to help us become more efficient and effective. We also need to look for ways to modify current laws and propose new laws to assist us in the performance of our duties. Your MACPO Legislative Committee and lobbyist have been reviewing the hundreds of new bills which affect the probation system. We have worked with the authors of some bills to modify their language and we have voiced our opposition and support for others. At the same time, it is the responsibility of corrections professionals to be aware of the proposed changes in law and make their feelings known. Subscribing to the House of Representatives' "Session Weekly" or viewing it online at www.house.mn/sessionweekly is a great start.

We also need to constantly remind our county commissioners and legislators that Minnesota's probation system continues to provide quality professional services to our courts, to our probationers, and to our communities in spite of our budget difficulties. The back cover of the March 19, 2010 "Session Weekly" listed some eye-opening statistics which support our good work. Examples include such statistics as: Minnesota spends 2.5 % of our General Fund on corrections as compared with the national average of 6.8%. 71% of the DOC's budget is spent on facility operations and programming. Minnesota ranks 49th in the number of offenders sent to prison and 4th in the number of offenders under community supervision. From these statistics you can see

that Minnesota's philosophy of supervising appropriate offenders in the community is very cost effective and that we comprise a small portion of the State's budget. Over the past several years we have been implementing the tools of Evidence Based Practices which make our community supervision efforts even more effective. However, unless adequate funding is provided to fund community supervision, regardless of the local probation service delivery system, we will not be able to continue this trend. These statistics and funding implications should be included in every discussion we have with our local and state public officials.
